Urgewald is a German non-profit which has been shedding light on controversial industry projects for more than 30 years. Our in-depth reports and impactful campaigns aim to prevent those projects by targeting the involved companies as well as the financiers behind them. Our data-driven approach eventually resulted in the creation of two unique fossil fuel company data sets: the Global Coal Exit List (GCEL) and the Global Oil & Gas Exit List (GOGEL). Today, almost 300 financial institutions from over 20 countries work with GOGEL data systematically to monitor oil and gas exposure, implement better oil and gas policies and to stop financial flows into new fossil fuel projects. Journalists, academics and fellow NGOs are using GOGEL in their research and campaigns. Urgewald employs more than 70 people in our offices in Sassenberg, Cologne and Berlin. The GOGEL research team consists of 12 people with a diverse set of skills, from a variety of cultural and professional backgrounds and generations.

- Researching company-level data, mainly in China
 - ➔ Gather GOGEL's power portfolio data and determine companies' fossil fuel share of revenue
- Researching project-level data, mainly in China
 - ➔ Gather the underlying information for our oil & gas expansion metrics on pipelines, LNG terminals and power stations
